**RE: Submittal of Desired Future Conditions on Behalf of Groundwater Management Area 7**

Dear Mr. Walker:

The groundwater conservation districts in Groundwater Management Area 7 met in San Angelo, Texas on March 23, 2017, and adopted the attached resolutions regarding desired future conditions for the Capitan Reef Complex, Edwards-Trinity (Plateau), Pecos Valley, and Trinity aquifers.

Because of TWDB review of GMA 3 desired future conditions, an issue was identified in the calculation of some of the average drawdowns in the Edwards-Trinity (Plateau) and Pecos Valley aquifers that were also present in the GMA 7 desired future conditions. Consequently, GMA 7 met in San Angelo, Texas on March 22, 2018 to adopt an updated resolution that corrected the average drawdowns.

The groundwater conservation districts in Groundwater Management Area 7 authorized me to submit the required materials to the Texas Water Development Board in accordance with section 356.32 of the Texas Administrative Code.

Based on the information provided in the TWDB's informational flyer, the five elements required are included with this letter and accompanying files.

An external hard drive with all the files have been hand delivered along with this letter.

The material is organized in six main folders:

- The folder labeled "Capitan" includes the explanatory report, model files, and the technical memorandum for the Capitan Reef Complex Aquifer.
- The folder labeled "Cover Letter" contains this letter
- The folder labeled "ETPlateauPecos" includes the explanatory report, model files and technical memoranda for the Edwards-Trinity (Plateau), Pecos Valley, and Trinity aquifers.

- The folder labeled “Notices” includes the posted meeting notices for the March 23, 2017 and March 22, 2018 GMA 7 meetings.
- The folder labeled “ValVerde” includes the report, predictive simulation files, and calibrated model files that were used in the development of the desired future condition for Val Verde County.

It should be noted that no files are provided for the Kinney County desired future condition since GMA 7 adopted the same desired future condition as 2010 (i.e. no change).


